

#### Why do you wish to carry out this role?

The reason I feel confident to apply for this appointment is that for the past five years I have been working as a volunteer advising and suggesting ways and means parts of the hospital might improve there admission letters, signage, to help people find there way around the hospital and helping when visually impaired patients are admitted so they don't feel isolated.

I have gained this knowledge by being a member of BPAC Bristol phisical access chain, a voluntary committee working through Bristol City Council and made up by all types of people who are disabled.

BPAC was formed following the new Disabled Discrimination Act introduced in 1993 and introduced over the next 10 years.

Over the time I have worked on BPAC I have learned about the medical model and the social model when assessing disabilities. I know about building regulations and how these can be applied to improve access and prevent careless accidents. I have spent time as a patient in the Bristol eye hospital where things might be improved with some consultation. Lucky for me I have not had a stay in hospital since the age of nineteen when I was admitted to Queen Elizabeth hospital in Birmingham for my left eye to be extracted. This was in 1957 and I have seen many changes since then.

Recently I have attended meetings called by Tony Watkins to discuss in-patient care and trying to improve problems when some people get discharged.
