

Please note the following data relates to inpatients/day cases at Bristol Royal Hospital for Children only, and patients with a diagnostic code of Q00-Q99. Patients may have had multiple contacts with the clinical services as a result the data can be counted in two ways based on the request.

The table below counts the first instance of patient contact in each year. As a result the same patient may be counted once in each year.
