Thank you for your request for information under the Freedom of Information Act 2000. The Trusts response is as follows:

- **Please provide full names of the doctors, their GMC numbers, start dates of current post, end date for current post and the sub-specialist interest they are being trained in.**

Please note we have not provided the names or GMC numbers as under Section 40(2) of the Freedom of Information Act, relating to a breach of Principle 1 of the Data Protection Act we are required to judge as to whether the disclosure of the information would be fair and reasonable to our employees. We do not believe that disclosing names or GMC numbers of individuals to a third party would be fair or reasonable and we are therefore unable to disclose the requested information.
