1. How many child patients with leukaemia do you have per year?

33

2. How many of them are ALL and how many are AML?

ALL - 24

AML - 8

3. Is the rehabilitation or aerobic load part of treatment?
4. How do you indicate the patient for rehabilitation?
5. How do you look through patients – do you use some standardised tests?
6. What does rehabilitation include? (Physiotherapy, ergo therapy, logopedia, play therapist...)
7. How do you indicate the patient for rehabilitation?
8. What are the main reasons for rehabilitation?
9. Do you have various rehabilitation (intensity, frequency, tests, etc.) according the phase of treatment (induction, consolidation, reinduction, maintenance phase)? How?
10. Or do you have some special program during the therapy?
11. How many leukaemia patients do you normally have for rehabilitation in one month and how many physiotherapists are working with them?
12. How many many of treaten children with leukaemia are indicated for rehabilitation at your clinic per year (approximately what percentage is also enough)?
13. And do you have some researches about rehabilitation programs? Which?
14. How does the rehabilitation look for inpatient and outpatient?
15. Which treatment protokols are you using for your patients?
16. Which methods and physiotherapeutic concepts do you use?
17. Can you please recomend me others hospitals which I should contact too?
