Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

Please note that we have provided below translation (written) and interpreting (spoken) services rather that only 'translation' services.

- 1. Could I please request the total amount University Hospitals Bristol NHS Foundation Trust spent on translation services in the following financial years:
  - a. 2016-17= £188,999\*
  - b. 2017-18= £313,862\*
  - c. 2018-19= £389,747\*

Total amounts for each financial year are made up of overall translating and interpreting spend for that year (total of figures below in Q2).

2. In each year, please separately state the amount spent on interpreters/oral communication and the amount spent on written, translated material. If possible, please state separately the amount spent on translation services for the hearing impaired (i.e. BSL and braille).

Face to face spoken language interpreting: £119,213\*

Telephone interpreting: £13,836\*

Written translation: £2,099\*

Face to face non-spoken language interpreting: £53,851\*

## 2017/18

Face to face spoken language interpreting: £233,247\*

Telephone interpreting: £20,570\*

Written translation: £533\*

Face to face non-spoken language interpreting: £59,512\*

#### 2018/19

Face to face spoken language interpreting: £292,755\*

Telephone interpreting: £16,070\* Written translation: £18,515\*

Face to face non-spoken language interpreting: £62,407\*

\*Please note: The Trust does not have a central budget for translating and interpreting services and as a result these figures are based on what is recorded on our finance system.
