 - a. their sex: Female 121, male 10.
 - b. their age: University Hospitals Bristol NHS Foundation Trust takes the view that this information is exempt from disclosure in accordance with section 40(2) of the Freedom of Information Act 2000. Section 40 is the exemption for personal information. The reason why the Trust takes this view is that this breakdown will produce low numbers that can cause patients being identified. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1, therefore find that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged.

 - a. their sex: Female 178, Male 31.
 - b. their age: University Hospitals Bristol NHS Foundation Trust takes the view that this information is exempt from disclosure in accordance with section 40(2) of the Freedom of Information Act 2000. Section 40 is the exemption for personal information. The reason why the Trust takes this view is that this breakdown will produce low numbers that can cause patients being identified. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1, therefore find that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged..
