Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

Request:

- The total pipeline of public sector projects involving any aspect of the Built Environment, Construction, Consultancy Services or Professional Services in any capacity;
- The total value of these projects;
- The expected benefits and high level policy outcomes of these projects;
- Descriptive information for each of these projects, including location, value, and procuring authority;
- Descriptive information for any other public sector projects involving any aspect of the Built Environment, Construction, Consultancy Services or Professional Services in any capacity.

Response:

To respond to your FOI request would take the Trust more than 18 hours to complete and is therefore exempt from disclosure under Section 12 of the Freedom of Information Act.

The below information that the Trust can provide is of definite new build developments that the Trust is currently progressing. It does not include any proposed / potential ideas of other new builds, which are not yet formally approved by the Trust. It also excludes any internal redesign or redevelopment works which are within the confines of our existing estate.

1. Four-storey extension to The Bristol Heart Institute (levels 5, 6, 7 and 8) to accommodate 2 x additional cath labs and expand inpatient bed capacity at levels 7 & 8 (6 extra beds on each level).

2. Separate four storey extension to Bristol Heart Institute to accommodate a Cardiovascular Research Unit, comprised of laboratories and offices.
