NEWS 2 was recently purchased from OCB Media Ltd, Leicester, LE1 6RX, replacing NEWS: Acute Care as listed on the report.
In addition, regarding the provider for ReSPECT (Worcester Acute Hospitals NHS Trust), Worcester was the body that created the original training materials. The components themselves were provided free of charge by West of England Academic Health Science Network.
- f. What is the total cost to the organisation for the e-learning.
32,012.40 including VAT.
- g. Please outline the payment structure of the e-learning (ie. is it a one-off cost or a rolling annual cost?).
Last payment was one-off payment for 12-month extension of contract.
- h. Was the e-learning course CPD accredited?
This varies depending upon the programme and if the course is mandatory. Currently most of the eleven nationally-recognised

core skills e-learning programmes, that we use as updates, have a CPD certificate attached, which notes the number of CPD hours awarded.
