The Trust is using Sunquest ICE until 2020 and is moving to System C – Medway.
The System C Medway end date is 2024.
15. Does the Trust plan to replace its Order Communications and Results within the next 5 years?
Yes the Trust is moving to supplier System C, software Medway.
16. What EPMA system does the Trust use and what are the supplier contract dates?
System C up to 2024.
